LETTER OF RECOMMENDATION

regarding the works performed by S.C. ELECTROSERVICE R.B. S.R.L.
BUCHAREST for the trading company RAFINARIA STEAUA ROMANA
CAMPINA

S.C. ELECTROSERVICE R.B. S.R.L. is a production and service supply company whose main activity consists of mounting and repairing power equipment: steam turbines, electric generators, hydraulic pumps, power, control and protection electric circuits.

The company may cover the whole range of works necessary for the machine chamber of the central heating stations and for this reason, in 1999, we selected it to perform the overhauling of the 2.5 MW turbo-generator in CET – Rafinarie, as well as to perform the periodical annual inspections on the same unit.

S.C. Electroservice R.B. has qualified, highly experienced personnel, as well as a headquarters which includes a very well equipped production and repairing workshop, a financial – accounting department and an engineering and forecasting workshop.

For the overhauling of the 2.5 MW turbo-unit, the works were performed during the period of time October 5, 1999, when the face was handed over and January 10, 2000, when the 72 hours operation test was performed.

It must be mentioned that the spare parts for this overhauling were made available to the contractor by the trading company "Rafinaria Steaua Romana" because they existed in the warehouse as spare parts, whereas the repairing works were of highest quality. The proof of the above-said is the fact-finding reports issued by the Installation Control Department on July 2000, in which it is specified that the condition of the turbine, of the bearings and of the other components is perfect.

The next works on the turbo-unit lasted 10 days in the spring of 2001 and 10 days in that of 2002, when the scheduled periodical technical inspections were performed. After these works were performed, both the turbine and the generator have worked normally and without encountering any technical failure between inspections.

After each intervention by the contractor, the 2.5 MW turbo-generator in CET – Rafinarie received warranty periods of 1 year.

The works performed by S.C. Electroservice R.B. in Bucharest are in accordance with the quality norms ISO 9002, whereas the company is certified by the trading company ELECTRICA S.A. and by SRAC, which recommends it as a company performing high quality works within the deadlines set down by contract.
