LETTER OF RECOMMENDATION

We specify herein that the company **S.C. Electroservice R.B. SRL Bucuresti** has performed the following repairing works for S.C. Uzina Termoelectrica Giurgiu S.A.:

- internal revision by measuring and renewing the clearance of the components of the adjusting system of the turbine Type DSL 50 (servomotors, summarization valves, main oil pump, etc.); stand tests on components; establishing its offset characteristic and insensitiveness; adjustment of the regulating system in order to bring the features within the limits set down in the technical documentation of the turbine no. 1 Type DSL 50 in CET Giurgiu;
- revision of the bearings of the DSL 50 turbine and of the bearings of the TH 60 generator and alignment of the rotors of the turbo-unit (performing the shafts line);
- revision of the packing bearings of the TH 60 generator;
- repairing of the cartridge of the supply pump Type EPA 500 – 180;
- repairing of the rotor and rewinding of the electric motor stator – 3800 kw actuating the supply pumps Type EPA 500 – 180.

The works were of good quality and in accordance with ISO 9002 – 1995.

Since the commissioning of the repaired machines, no failure has appeared and the equipment has worked normally in operation.
